**ADULT PART-TIME GRANT**  
Established by the State of Michigan  
Act 102 of 1986

---

**WHO IS ELIGIBLE?**

Part-time students who are enrolled or accepted for enrollment for not less than three (3) credits or more than eleven (11) credits and are enrolled in an undergraduate program of not less than nine (9) months duration leading to a certificate or degree at **Northwestern Michigan College (NMC)**.

---

**INDEPENDENT STUDENTS (SELF-SUPPORTING)**

Students must meet the qualifications of an independent student as defined by Federal Regulations for Title IV financial assistance (Refer to the Free Application for Federal Student Aid (FAFSA) for a definition).

---

**FINANCIAL NEED**

As determined by the results of the FAFSA.

---

**MICHIGAN RESIDENTS (U.S. CITIZEN OR PERMANENT RESIDENT)**

Students **MUST have resided continuously in Michigan for the twelve (12) months immediately preceding** the award year and not be considered a resident of any other state. Verification is **required** by providing one of the following:

- 2008-2009 FAFSA with MI as legal state of residence (question 18) AND question 19 with yes answer *or* question 20 with answer before January 1, 2007
- 2007 Michigan Tax Return
- 2007 IRS Tax Return with Michigan address
- Social Services Annual Income Statement for 2007
- Military/Ministry personnel certificate or letter denoting Michigan residency

---

**STUDENTS WHO HAVE NOT BEEN ENROLLED  
IN A HIGH SCHOOL DIPLOMA PROGRAM DURING THE PAST TWO YEARS**

To be eligible, a student must have been out of a high school program for at least two (2) years preceding the award period. **Students may be asked to provide NMC documentation as proof.** Students may be eligible who were enrolled and completed a GED or adult education program.

---

**OTHER CRITERIA FOR STUDENT ELIGIBILITY**

- Must not be in default on any Federal Family Educational Loan or owe a Title IV refund
- Must not be currently incarcerated in a corrections institution
- Must make satisfactory academic progress (see current college catalog)

---

**WHAT IS THE AMOUNT OF THE PART-TIME GRANT?**

The amount of the grant cannot exceed \$600 per year, and for not more than 24 months of funding for attendance at any participating school.

Award priority will be given to eligible students with the greatest financial need.
