2. Student must complete the first and second years of the Wexford-Missaukee CTC Computer Systems and Infrastructure Technology (CSIT) program with a grade of B or better and achieve the required competencies.
3. Student must present their credentials indicating they have completed and passed a CompTIA CertMaster Certificate of Competency or CompTIA certification listed above.
Note: The certification must be a current certification. Certifications that are older than three years will be considered on an individual basis.
4. NMC instructor will evaluate the student's learning based on the course objectives, course work, and assessments, and if necessary, require an NMC written competency evaluation and/or portfolio artifacts.
